

Who are we?

The group has existed since 2000 and continues to seek to make an impact on the conservation of barn owls in the North, South, East & Mid Cheshire area. We are people from many walks of life with varying degrees of knowledge about barn owls but are united in our concern about the decline of this wonderful bird and want to contribute to it's survival.

Why?

In 1932 there were 240 pairs of barn owls in Cheshire but by 1985 there were just 35 pairs. This represented a decline in Cheshire of 85% against an average decline of 69% in England & Wales. That was bad enough but worse was to follow and in 1999 only 10 breeding pairs were recorded in Cheshire.


So, despite the barn owls having had special protection under the Wildlife and Countryside Act 1981, numbers steadily declined. We aim to reverse this trend in Cheshire. Indeed, by 2007, through the work of this and other like minded groups in Cheshire, the numbers of barn owls has shown a steady recovery to over 150 pairs.

What can be done?

There is an enormous amount of work still to do, including:

- | Record and follow up sightings
- | Locate and protect existing breeding sites
- | Locate and develop suitable breeding sites, providing nest boxes if necessary
- | Encourage the creation or recovery of suitable habitats for hunting and breeding
- | Monitor the population of barn owls in the area
- | Work together with any organisation or individual that has an impact on the conservation of barn owls.

Types of Membership

- 1. Standard Membership
£5.00 per year per family

For landowner confidentiality reasons it may not be possible to inform the member of the exact location of the box sponsored by them but the box allocated will be as close as reasonably possible to their home address.
